3. <u>CONTINUED DISCUSSION – Proposal for Zone Change, 42 Route 30 from Residential to Commercial,</u> <u>Ellen Moor, Applicant.</u>

Ellen Moor approached the Commission. Ms. Moor reviewed her proposal to re-zone 42 Route 39 from Residential to Commercial. The Commission discussed and stated the next step would be to make a formal proposal.

4. <u>DISCUSSION – Sherman Hotchkiss Property – Illegal structures</u>

Mr. Hotchkiss approached the Commission. He asked the Commission to consider perocity of soil when calculation maximum coverage. He explained his soil has good drainage and asked them to think about a zoning variance on lot coverage.

The ZEO reported the reviewed the 2013 site plan and 25.7% coverage was approved. Now the plan is showing 31.7% coverage and the plan was not approved. Mr. Hanrahan asked how the percentage had changed and Mr. White reported Mr. Hotchkiss added stairs that changed the coverage.

Mr. Van Vlack explained the history and process the Commission went thru to get to the 25%. Mr. Moran stated Mr. Hotchkiss would have to apply for a zone change.

5. Site Plan Modification- Dumpster Relocation 88 Route 39, Fieldstone Plaza

Mr. Mike Chamoures approached the Commission. The Commission reviewed the Site Plan and the location of the dumpster. Mr. Moran stated a pad is needed and screening, where located is an internal issue.
