# 2. Request for change in zoning regulations to increase the size of the signs allowed in the Candlewood Corners Village District Zone, Atty. Richard Smith agent

Attorney Richard Smith representing Dr. Lorraine Burrio approached the Commission. Atty. Smith reviewed the history of the Neighborhood Business District. Dr. Burrio has a concern about the size of the sign she is allowed. He explained they feel it creates a hazard when people are driving and looking for it.. He also felt the sign at the Sunoco and Motel were a distraction. He came to discuss the possibility of enlarging the size of the signs permitted in that district.

Atty Smith submitted letters from Dr. Burrio's patients stating their concerns about the sign. He also submitted pictures of the area comparing the size of the signs.

Atty Smith distributed a drawing of what they were proposing. Mr. Zering asked about lighting. Atty Smith would like it but he wasn't sure if it was permitted.

The Commission discussed the location of the sign.

Atty Smith submitted proposed language. Mr. Moran read the proposal into the record.

Mr. Hanrahan stated the proposed sign he submitted already exceeds the language that was proposed.

Mr. Moran asked the Commission to drive by the area and see if they agree with the assumption that the sign can't be seen and is a safety hazard. Atty. Smith asked that they drive by at night as well. The Commission will discuss next month.

# 3. Special Permit Application for an In Law Apartment for Larry J Penna; 11 Donnelly Drive in New Fairfield

Mr. Larry Penna approached the Commission. Mr. Moran reviewed the process. Mr. Gormley stated in his opinion the application meets the regulations.
