OLD BUSINESS

COVID 19 update

Pat Del Monaco noted that the infection rate for COVID 19 in New Fairfield continues to rise. It was noted that the new variants of the virus are both more contagious and more sickly. As a result, all residents are encouraged to continue to wear a mask and to practice social distancing.

Approximately, 28.5% of New Fairfield residents have received at least one dose of the vaccine. As of April 1, 2021, the vaccine will be available to all Connecticut residents over 16.

Selectman Khris Hall noted that 500 doses of the vaccine will be given last week and 400 this week. These doses were all the Moderna vaccine. It is hopeful that the town will receive doses of the Johnson and Johnson vaccine in the coming weeks. She thanked both the medical and non medical volunteers that have been working at the clinic and noted that everything is running very smoothly.

There was a brief discussion among the BOS regarding concerns of the numbers of infections rising in New Fairfield. The BOS discussed ways to address this and to encourage residents to be safe. There will be an article in next week's Town Tribune.

Discussion of the BOS 2021/2022 budget

Pat Del Monaco noted that the BOF has asked the BOS to come up with \$150,000 of cuts to their operating budget for the 2021/2022 budget. First Selectman Del Monaco and Finance Director Ed Sbordone spoke of the following proposed cuts:

- Worker's Compensation- \$20,000
- State Police- \$40.000
- Union salaries- \$10,000
- Road repair- \$80,000

Kim Hanson spoke of his concerns regarding the cuts to road repair and his desire to see salaries cut instead. Pat Del Monaco spoke of the possibility of using some of the funds from the American Rescue Plan to fund some of these cuts.

Approval of Letter of Credit Reduction for Hearth Home Builders

Pat Del Monaco made a motion to approve the letter of credit reduction for Hearth Home Builders #91332479 dated September 26, 2014 in the amount of \$500,000 to a reduced total of \$60,000.00. Kim Hanson seconded the motion. **Vote: 3-0-0 (Motion approved)**

Executive Session for 13 and 15 Route 37
