**Call To Order** First Selectman Pat Del Monaco called the meeting to order at 7:30pm.

## **Correspondence and Announcements**

Kim Hanson referred to a correspondence sent by Bob Balas regarding the possibility of finding a place for the Veteran's Association to store thier cars as they are losing their current spot. There was a brief discussion of ways to help this situation.

Khris Hall noted that the last day for the New Fairfield Vaccine Clinic is Thursday, May 20<sup>th</sup>. She spoke of the possibility of having a vaccine clinic for children ages 12-15 but noted that since there are many other clinic now available, it doesn't seem to be enough of demand.

## **OLD BUSINESS**

#### **COVID 19/Vaccine update**

Pat Del Monaco gave an update regarding COVID-19. She noted that the case rate is currently down to 7 per 100,000 people which is the lowest since Summer 2020. There is a 2% test positivity rate. She spoke of concerns that the vaccination rate inn New Fairfield has plateaued and is currently lower than surrounding towns. She encouraged everyone that hasn't yet to get vaccinated.

Pat Del Monaco noted that the Governor's Emergency powers have been extended until July 20<sup>th</sup>. It is expected that the order allowing for remote meetings and provisions for absentee voting will be extended

The entire BOS encouraged residents to get vaccinated so that herd immunity can be reached. Parents of young teens were encouraged to get their children vaccinated.

#### **Noise Ordinance**

Khris Hall spoke of some amendments to the proposed noise ordinance specifically:

- The time frames
- The addition of ATVs as snow removal equipment
- Restrictions for chickens

Pat Del Monaco noted that this ordinance would need to be approved at a Town Meeting.

## American Rescue Plan update

Pat Del Monaco gave a brief description of the American Rescue plan and noted that it meant to fund future expenses or anything that occurred after March 2021. She spoke of the restrictions for these funds and the possibility of forming an Ad Hoc committee to research the best ways to use these funds. There was a brief discussion of the which groups should be represented at this committee.

### **Discussion and vote on Community Garden Agreement for 2021**

Pat Del Monaco noted that she reviewed this agreement and there are only minor changes from previous years.

Pat Del Monaco made a motion to approve the Community Garden Agreement for 2021. Kim Hanson seconded the motion. **Vote: 3-0-0 (Motion approved)** 

## Discussion and vote to alter the date of the Annual Town Budget Meeting

There was a brief discussion of the date for the Town Meeting. It was noted that the purpose of this meeting is just to set the date for the machine vote referendum.

Pat Del Monaco made a motion to alter the date of the Annual Town Budget meeting to May 27, 2021. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)** 

## Discussion and vote on Warning for the Annual Town meetings

There was a discussion about the best way to conduct the Annual Town meeting and whether or not it is better to have it in-person or held virtually. It was decided that an in-person meeting at Meeting House Hill School would be the best option.

Pat Del Monaco made a motion to approve the following Town Meeting Warning: Notice is hereby given to the electors of the Town of New Fairfield and those qualified to vote at an Annual Town Meeting to be held on May 27, 2021 at 7:00 pm. in the MHHS Multipurpose Room for the following purposes.

- 1. To consider and act upon the appropriation of Town Government Expenditures totaling \$12,860,682 from the General Fund, and \$770,213 from the Capital and Non-Recurring Fund, and \$914,231 from other Governmental Funds, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2021 and ending June 30, 2022.
- 2. To consider and act upon the appropriation of Education Expenditures totaling \$45,311,219 from the General Fund, and \$93,389 from the Capital and Non-Recurring Fund, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2021 and ending June 30, 2022.

Further notice is hereby given that the Board of Selectmen, acting pursuant to and in reliance on Section 7-7 of the Connecticut General Statutes, has removed Item #1 & #2 for submission to the voters by machine vote and shall be no earlier than seven (7) days, and no later than fourteen (14) days after May 27, 2021 and further provided that such time shall be no less than the hours of 12:00 Noon to 8:00 pn.

### **Vote on resolutions for NFHS Pool Locker Rooms**

Director of Business and Operations Dr. Rich Sanzo spoke of revised resolutions for the pool locker rooms for the new high school project. The reason for the revised resolutions is that the State has asked that this portion of the project be separated out from the rest of the project for

grant purposes. It was noted that this change in application will not affect the budget for this project.

Pat Del Monaco made a motion to accept the following resolutions:

RESOLVED, that the Board of Selectmen authorizes the New Fairfield Board of Education to apply to the Commissioner of Administrative Services and to accept or reject a grant for the new construction at the New Fairfield High School, including the existing pool locker rooms; and

RESOLVED, that the Permanent Building Committee is hereby established as the building committee with regard to the new construction at the New Fairfield High School, including the existing pool locker rooms; and

RESOLVED, that the Board of Selectmen hereby authorizes at least the preparation of schematic drawings and outline specifications for the new construction at the New Fairfield High School, including the existing pool locker rooms. Khris Hall seconded the motion.
