COVID 19/Vaccine update

Pat Del Monaco gave an update regarding COVID-19. She noted that the case rate as of May 20th was currently 8.2 per 100,000 and the test positivity rate is 2.5% which is higher than the State average. She further noted that New Fairfield has one of the lowest vaccination rate in the area. There was a brief discussion of how to increase the vaccination rate in New Fairfield. Khris Hall noted that instead of setting up a vaccination clinic for teens, it was decided that the Town will do an extensive advertising campaigns about the benefits of being vaccination and how easy it is to get done.

American Rescue Plan update

Pat Del Monaco noted that she has not received any recent information on the American Rescue Plan but will be attending a CCM Presentation regarding this on June 3rd.

Noise Ordinance
