New Business:

<u>Discussion of request for 8-24 referral regarding the Zoning Commission</u> proposing a hospital regional facility of 10,000 square feet-

A petition was received to change the zoning boundaries as follows-

- -To change the zoning classification
- -To provide construction of a medical facility
- -Be seen as a consistent zone and land use of budding properties
- -The property has a petition to be converted from NB (neighborhood business district) to BC (business commercial district)
- A positive or negative referral would have to be sent out to the Zoning Commision
- -Changes were made in taxation by the state legislature in regard to the ability to levy taxes by towns against hospitals.
- -Overriding action on this plan would require a town vote.
- -There is not enough information presented before us to take action on this referral.

Ernie Lehman made a motion to postpone pending discussion on the involved parties of the 8-24 referral for the hospital regional facility. Jeff Morrell seconded the motion. Vote 5-0-0. (Motion approved)

POCD Updates-

Cynthia Ross Zweig touched base with the selectman and she advised we would have to bid out all over again. The current bid would have to be updated to regard the traffic plan. The last traffic study was conducted in 2012. The budget for this is \$3000.

Budget-\$5434.56 is remaining the the budget balance, and \$3000 of it is currently intended to go to the traffic study meaning the remaining balance will be \$2434.56.

Cynthia Ross Zweig made a motion to amend the agenda to allow for the subdivision update. Seconded by Cory Neumann. Vote 5-0-0. (Motion approved)

Barn Brook Estates needs to fire tank and second phase of blacktop to be put in. Due to be done in Spring 2019.
