Old Business

Discussion of 8-24 Referral, sale Town of New Fairfield Water System to Aquarion Water Co.

System is run by two volunteers with aging equipment. System failure would be a liability on the town in that it would have to provide water to the town should it fail. Selling of the Water System will provide a reliable source of water to the center of town. The system currently serves approximately 100 people/businesses in the center of town. Sale price is \$150,000.00. Sanitary easement fee is part of the sale of the property.

Aquarion will be responsible for speaking with owners of privately owned properties which are affected by the 200' easement.

Carolyn Rowan - if a private property owner wanted to drill another well on their property would the easement affect. These homes have septic in the back yards and wells would not be drilled there in any case.

Addition of the new water system will provide more water and more reliability to downtown area and may attract additional businesses.

Greg Williams - Will the easement be negotiated separately with each

property owner. Per Aquarion, yes, they will speak with each owner. Fees to existing property owners will either be similar or possibly be lower.
