NEW BUSINES

1. <u>DISCUSSION – Solar Energy Installation by Board of Education</u>

Ms. Ross-Zweig reported she attended the August Board of Education meeting and they discussed adding solar panels to Meeting House Hill School. As of now the Planning Commission has not received any correspondence on the project. She felt it was a Municipal building, and reviewed State Statute 8-24. Ms. Ross-Zweig read the statute into the record. Ms. Ross-Zweig spoke with Atty. Slater and he felt it fell under leased equipment.

The Commission discussed what their role in this would be.

Ms. Bennett-O'Rourke felt it was beyond the scope of the Planning Commission. Ms. Ross-Zweig felt that wasn't clear until we see the plans. Mr. Bruno was concerned a precedent would be set, and it should be part of the process. Ms. Ross-Zweig will send an email reminding the Board of Education the statute.

2. DISCUSSION - Review of Yearly Commission goals as outlined in the POCD

Ms. Ross-Zweig the state statute calls for planning to review yearly Commission goals and ask if they were met, changed or extended. She explained she spoke with Attorney Slater and asked for an idea if other CT Towns in the area were already in the process of writing a letter. The POCD can be updated with the state regularly, we don't have to wait 10 years.
