Public Comment

Susan Monshaw, New Fairfield, CT approached the Commission. She requested a discussion of proposed Zoning change.

Ms. Monshaw explained she was representing "Preserve Historic New Fairfield" and they were proposing a move of the Hubbel House and the Parsonage with an idea to create a museum district. The Commission reviewed the proposed plans. Ms. Fox explained currently the regulations allow museums in residential areas, she was not sure it was necessary to create a zone.

Mr. John Hodge, First Selectman commented they were asking for a zone because ultimately they would like to add buildings and work toward establishing a village. Mr. Mitchell agreed because that would allow notification of neighbors.

Business Items

3. <u>Continued Violation – 1 Pine Hill Road, Expired appeal time Cease & Desist Notice – Pet Chickens.</u> Susanne & Joe Istvan, owner.

Mr. & Mrs. Istvan approached the Commission. Ms. Istvan presented a document signed by Mr. Dan Gerow stating Joe Istvan, Sr. always had poultry on the property for at least 10 years. Mr. Peter Ballard stated Mr. Istvan, Sr. had poultry from at least 1971.

Ms. Fox stated the Town Attorney's comment stated if the Commission felt it was consistent with the property in the neighborhood.

Mr. Tom Rywalt, owner of 136 acres of farmland on Pine Hill felt it was consistent with the neighborhood. Ms. Istvan stated it was 13 chickens.

6. <u>06-06 Site Plan Modification – 28 Rt. 39 – Bruno's Pizzeria – Expand into adjoining unit. Peter Young, agent.</u>

Mr. Peter Young, representing Anthony Bruno approached the Commission. Mr. Young distributed proposed plans. He explained Mr. Bruno was going 1,800 sq. ft. increasing his seating capacity from 18 to 35.

Ms. Fox read a letter from Tim Simpkins, NF Health Director dated 2/3/06 into the record with no objections.

The ZEO read a letter into the record from Michael Crawford, NF Fire Marshall stating the proposal was in compliance with CT state code.

The ZEO reviewed the parking. She stated he needed 14 more for a total of 28 spaces for both units, and they were available. No additional signage.
