## Regular Meeting May 1, 2007

Meeting called to order at 7:35 p.m. by chair Faline Schneiderman-Fox.

### **Public Comment**

Mr. Dave Arnold, 17 Ball Pond Road approached the Commission. He made a complaint against Boyagian Sculpture Barn. Ms. Schneiderman-Fox explained the variance issued stated they could have 4 events per year. She also explained the ZEO was pursuing a cease and desist order on the property.

# 2. Special Permit 06-07 – 31, 33 and 39 Route 37 – Revision to Senior Center Building and Municipal Office Building. Town of New Fairfield, applicant.

Mr. Ralph Gallagher, Mr. John Hodge, First Selectman; and Mr. Bob Rawlings, Chair PBC approached the Commission.

Mr. Gallagher reviewed the Town Engineer's letter dated 4/9/07, addressed the issues and reviewed the changes. Mr. Hodge stated he wanted to talk to Mr. Iadorola about the fence for the spillway, he felt it was the scenic area of the property. The Commission didn't feel it was necessary to fence in the waterfall.

Mr. Gallagher stated the old stone well would be capped properly. He reviewed the ZEO issue stating the sidewalks would be ADA compliant with 42" railings installed.

The Commission discussed the location of the dumpster. Low level lighting is to be installed across the bridge, on the walkways and on the building.

The Commission reviewed the stipulations.

- 1. lighting wanted on the bridge
- 2. Move dumpster to a better location.
- 3. Same plantings as approved.
