OLD BUSINESS

Approval of contract for Plan of Conservation and Development

Cynthia Ross-Zweig noted that the contract has been received from the firm of Milone and MacBroom for the Plan of Conservation and Development. Ms. Ross-Zweig spoke of three suggestions for the contract:

- Consultant will assume all costs for mailings, newspaper notices, flyers and any telecommunication costs including design material and postage. The consultant has agreed to this with a \$1,000 increase in price.
- Consultant will include agricultural plan to comply with State statute that requires that each town has an agricultural plan.
- Consultant will review State statutory requirements as they relate to the Plan of Conservation and Development and insure that the town is in compliance.

It was noted that payment to the consultant is paid on a monthly basis based on amount of work completed.

Other suggestions made by the commission were to add Senior Housing to the plan and should address Community Facilities and Infrastructure as well as transportation.

Lisa Deldin made a motion to approve the contract for the Plan of Conservation and Development from the firm of Milone and MacBroom and to forward to Town Counsel for review. Mike Daood seconded the motion.
