OLD BUSINESS:

1. Grant Award for Resource Directory

3. New Senior Center Update

Discussion focused on the new architectural firm is Lazarus and Sargeant and although this is the original firm, they are not using the original architect. The new senior center will be a modular with a flat roof with a fence to hide the mechanics. The new senior center will be approximately 8,500 (eight thousand five hundred) square feet and the existing home is staying. Parking and the layout of the new senior center were also discussed. Due to the design changes the senior center must go back to Zoning and Zoning Board of Appeals and are on their Agendas for September 2, 2008.
