1. Summit Meeting April 5

2. Update on the New Senior Center

The Permanent Building Committee {PBC} has held several Special Meetings regarding the New Senior Center and it appears the leg work is in the final stages and building can finally start. The grant stipulates that certain requirements must be met by October 15, 2008.

1. Supportive Elderly Housing:

Tom Dube from the Lutheran Church held a meeting regarding what he calls "Supportive Elderly Housing". Attendees included Maureen Salerno, Kathy Hull, and people from the community with various interests who represented various boards and commissions. A slide presentation was shown. The Lutheran Church hopes to create a private non-profit and to build "Supportive Elderly Housing". They will apply to HUD for 202 grant money with the proper credentials. Tom Dube has been diligently looking into land in the center of Town. Discussion followed on properties in Town. Tom Dube was at the last BOS meeting to get the word out.
