# Town's five-year Cap & Non Plan from the Board of Selectmen

Pat Del Monaco spoke of project for the Capital and Nonrecurring five year plan and specifically two projects that are consistent with ARPA funds.

The first project discussed was the Ball Pond Watershed (Lower Merlin Ave) project designed to slow the amount of water shed and ease erosion. It is estimated that it would cost approximately \$150,000 to get this project to the point where the design is complete and it is shovel ready.

The second project discussed was the Sewer Study costing approximately \$1.5 million which would include the studies, surveys and design to make this project shovel ready in order to apply for federal and state money to complete the construction of the sewers.

There was a discussion of the unappropriated Cap and Non account and unassigned general fund.

# **Vote on Budget Surplus for Fiscal year 2020-2021**

Wes Marsh made a motion to recommend to a Town Meeting an Additional Appropriation in the amount of \$722,268.14 which represents 100% of the fiscal year 2020-2021 BOS Expenditure surplus and \$219,046.96 of the Revenue surplus. Michael Cammarota seconded the motion.
