<u>Call To Order</u> First Selectman Pat Del Monaco called the meeting to order at 7:30pm.

First Selectman Pat Del Monaco introduced Lori Bennison as the new Selectman.

## **Proclamation honoring Kim Hanson**

First Selectman Pat Del Monaco read a Proclamation honoring Kim Hanson for the many volunteer roles that he served in New Fairfield for the last two decades.

Many members of the public thanked Mr. Hanson for all his years of service to New Fairfield.

### **Public Comment**

Ernie Lehman noted that recently elected Library Board Director Claudia Willard has resigned from the Library Board and asked to be considered as a director in her place. First Selectman Del Monaco asked Mr. Lehman to send a brief email with his intention.

Kim Hanson spoke of revisions to the Animal Control ordinance and asked if animals other than dogs could be included in this ordinance. First Selectman Del Monaco noted that by State Statute, Animal Control officers only deal with dogs.

### **Correspondence and Announcements.**

Selectman Khris Hall noted that the vaccination van will be at St. Edward's Church on November 24<sup>th</sup>. There will not be a vaccination clinic this Saturday, November 27<sup>th</sup> due to the Thanksgiving Holiday. The second pediatric clinic will be held on Saturday, December 4<sup>th</sup> for children only. The clinic on Saturday, December 11<sup>th</sup> will be for adults. There are not currently any plans to extend the clinic past the end of the year so residents are encouraged to get the vaccine as soon as possible. First Selectman Del Monaco thanked Selectman Hall for all the work she has done for the clinic.
