Personnel Report

NEW BUSINESS

Discussion and vote to revise Building Department Fees

Building official Eric Kist spoke of the process and fees associated with Certificate of Occupancy and Certificate of Approval. He noted that the current fee is difficult to collect especially with new homes. It is hopeful that the lower fees would be an incentive for homeowners to comply with the rules. It was decided that setting the fee to be "up to \$500" would give flexibility with setting fees.

Pat Del Monaco made a motion to revise the building department fees to include fees of up to \$500 as described in the Owner's Certification Form item C, D & E with the amendment that the permitee shall pay a fee of **up to \$500** in each paragraph. Lori Bennison seconded the motion. **Vote: 3-0-0 (Motion approved)**

Discussion and vote to approve purchase of NFVFD Ambulance

Pat Del Monaco spoke of the quote for the purchase of a new ambulance and noted that the price is 10% less if ordered before December 31, 2021.

Purchasing Agent Patty Mota spoke of the quote and asked questions to the members of the Fire Department. Members of the BOS asked questions of Fire Chief Bruce Taylor regarding the ambulance. There was a discussion of extended warranties and performance bonds.

Pat Del Monaco made a motion to approve \$275,000 for the purchase of a New Fairfield Volunteer Fire Department Ambulance with the stipulation that the Town's contribution limited to \$195,500. Lori Bennison seconded the motion. **Vote: 3-0-0 (Motion approved)**

Members of the Board of Selectman thanked the Fire Department for working hard to come up with this solution. Fire Chief Bruce Taylor thanked everyone for their work and cooperation with this purchase.

OLD BUSINESS COVID Update

Pat Del Monaco noted that the case rate for COVID is increasing at an alarming rate. Effective, December 27th appointments will be required for anyone wanting to go to Town Hall.
