Call to order:

OPM Update – Scott Pellman from Colliers noted they continue to work on preparing to bring the High School project reimbursement to the state. The schedule is still being updated to reflect the discussions at the last meeting.

CM Update

- CELA Construction update Joe Vetro stated the roof in area F is now watertight. Air and vapor barrier instillation is almost complete. The MEP rough in and interior framing are started. Exterior framing and sheathing are now complete. Area D roof curb instillation started, roof completion early next week. Area E roof installations materials are due to arrive on January 17th. Slab on grade is complete.
- HS Construction update Joe stated they are working on foundations and underground work at the High School. The slab has been poured in area C. The slab for area D is scheduled to be poured on Thursday. A and B foundations have been started. Steel is scheduled to be on site January 10th.

 Mike DelMonaco asked when the BMS submittal and commissioning test scripts would be made available for review. Joe stated he would send the information for CELA. He will send the HS when its complete.
