Pat Del Monaco noted that Mr. Timmy Shej from Timmy Masonry was due a return of a bond in the amount of \$1,000. Mr. Shej has generously offered to return this bond to the town as a donation. The Selectman thanked Mr. Shej for this donation as well as his recent donation of repairs to the chimney at Town Hall.

Approval of the 2022 Community Garden Agreement

Pat Del Monaco noted that this agreement was revised only to update dates on the agreement. The Selectmen spoke of the new location for the Community Garden and thanked everyone involved in its success.

Pat Del Monaco made a motion to approve the 2022 Community Garden Agreement. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)**

Discussion of 2022-2023 Budget

Pat Del Monaco gave an update of the budget and explained the process. She noted that each Town Department Head meets with the BOS to explain the needs for their respective department. She gave details of the components of the budget and noted that the total budget is approximately \$58 million with approximately \$45 million for the Board of Education and approximately \$12 million for the Town. She noted that 2022-2023 is a peak year for the school construction bonding in the amount of \$35 million. The cost of this bonding is less than originally estimated due to reductions in interest rates.

Pat Del Monaco spoke of Capital projects and the possibility of funding some of this through the unappropriated Capital and Nonrecurring fund instead of next year's budget. She also spoke of projects that can be deferred to future years.

A copy of the budget summary is posted to the Town's website. The BOS will vote to bring this budget to the Board of Finance at their next meeting.

OLD BUSINESS COVID update

Pat Del Monaco gave an update on COVID:

- Approximately 1600 test kits have been distributed to members of the community.
- An additional 200 have been kept on hand for first responders.
- Additional kits will be received for vulnerable populations including the schools.
- The Town is considering having a walk up PCR Testing facility at no cost to residents from the middle of February to April.
- Disabled residents in need of assistance in getting a COVID test should call the Selectmen's office.
- The State's positivity rate is down to 10% with cases in Town down from 200 to approximately 60. There is also a decrease in hospitalizations in Connecticut. Despite this, First Selectman Del Monaco cautioned residents to remain vigilant and to wear masks and to socially distant.
- It is hopeful that in-person activities in the Senior Center and Library will return by the second week of February.
