**OLD BUSINESS**

**1. Spring Community Forum:**

**2. Liaison to the Planning Commission :**

The Planning Commission sent a memo dated January 3, 2013 stating they are in the process of updating the Plan of Conservation and Development. **3. New Fairfield Housing Trust**

The New Fairfield Housing Trust is in the process of identifying property and investigating it to see if it is viable for senior housing. They are in the process of obtaining their 501C3 status. They will hold a Special Meeting on Thursday January 24, 2013. Cindy LaCour made a motion to take a short break, 2<sup>nd</sup> by Roberta Ilardo approved 5-0. ### **1. 2013/2014 Budget:**

### **2. Senior Center Report:**

Kathy Hull reported. Judy is not back to work yet. Kathy Hull handed out a chart showing how Connecticut's senior population has grown and is expected to grow over the next several years. Kathy Hull submitted this chart along with her 2013/2014 budget to support her request for a full time Program Coordinator. She requested a 3% increase on the salary line and raised the Program Line.
