OLD BUSINESS

the supply line, Kathy Hull is unable to increase the size of any of her PO's and she is not able to purchase supplies that she needs. Kathy Hull stated she has never over spent her budget and that this budget freeze is unfair.

2. <u>Fall Community Forum:</u>

The Commission discussed possibilities for the next Community Forum which will be held on Saturday morning October 25. The topic will be Affordable Elderly Housing. There was discussion on the Sherman Affordable Housing Project being shot down in the referendum. Perhaps having other towns come and talk about their experiences with Affordable Senior Housing, then the fear will not be so great. Further discussion focused on how to address the water and flooding concerns the residents of Rita Drive have. Local agencies will be asked if they would like to be a sponsor for the program. Perhaps charge \$100 per sponsor.
