Vote on Fair Housing Resolution, Town of New Fairfield

Pat Del Monaco made a motion to adopt the following Fair Housing Resolution as presented. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)**

It was noted that the town is required to adopt this resolution on an annual basis.

Whereas, All persons are afforded a right to full and equal housing opportunities in the neighborhood of their choice; and Whereas, Federal fair housing laws require that all individuals, regardless of race, color, religion, sex, handicap, familial status or national origin, be given equal access to all housing-related opportunities, including rental and homeownership opportunities, and be allowed to make free choices regarding housing location; and Whereas, Connecticut fair housing laws require that all individuals, regardless of race, creed, color, national origin, ancestry, sex, marital status, age, lawful source of income, familial status, learning disability, physical or mental disability, sexual orientation, or gender identity or expression be given equal access to all housing-related opportunities, including rental and home ownership opportunities, and be allowed to make free choices regarding housing location; and Whereas, The Town of New Fairfield is committed to upholding these laws, and realizes that these laws must be

supplemented by an Affirmative Statement publicly endorsing the right of all people to full and equal housing opportunities in the neighborhood of their choice. NOW THEREFORE, BE IT RESOVED, That the Town of New Fairfield hereby endorses a Fair Housing Policy to ensure equal opportunity for all persons to rent, purchase, obtain financing and enjoy all other housing-related services of their choice on a non-discriminatory basis as provided by state and federal law; and BE IT FURTHER RESOLVED, That the chief executive officer of the Town of New Fairfield or her designated representative is responsible for responding to and assisting any person who alleges to be the victim of an illegal discriminatory housing practice in the Town of New Fairfield and for advising such person of the right to file a complaint with the State of Connecticut Commission on Human Rights and Opportunities (CHRO) or the U.S. Department of Housing and Urban Development (HUD) or to seek assistance from the CT Fair Housing Center, legal services, or other fair housing organizations to protect his or her right to equal housing opportunities. Adopted by the Town of New Fairfield on April 14, 2022.

COVID update

Pat Del Monaco gave an update on COVID and reported that there are 10.6 cases per 100,000 in town and cautioned that this does not include home tests so the numbers may be a little low.
