NEW BUSINESS

1. <u>Senior Center Report:</u>

Kathy Hull handed out the 2014 annual Senior Center Report. Attendance was down this February due to the extreme cold weather and unusually excessive snow amounts. Thanks to the new system the statistics are easier to retrieve. In 2014 the average daily attendance was 84 with an annual attendance of 20,243. They served 5,109 meals which averages out to 22 meals per day. The total volunteer hours reported were 6,216.31. These hours have an in kind value of \$54,081.90 at the minimum wage of \$8.70 per hour. The old system of recording volunteer hours is no longer being utilized, the hours appear to be less, however, it is because many hours are not being recorded. There are lots of activities going on for March. Julie Blick will be at the Senior Center for "Tax Aid Day" on March 2 to help anyone eligible sign up for the tax relief program.
