## ANNUAL TOWN MEETING TOWN OF NEW FAIRFIELD

Notice is hereby given to the electors of the Town of New Fairfield and those qualified to vote at an Annual Town Meeting to be held on Tuesday, April 24, 2007 at 7:30 P.M. in the NF High School Library for the following purposes, to wit:

1. To consider and act upon the proposed Town Government expenditures totaling \$9,813,175 from the general fund, \$1,234,400 from the capital and non-recurring fund, and \$754,491 from other governmental funds, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2007 and ending June 30, 2008.
2. To consider and act upon the proposed Education expenditures totaling \$33,636,433 from the general fund, and \$140,000 from the capital and non recurring fund, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2007 and ending June 30, 2008.
3. To consider and approve the resolution entitled "Resolution appropriating an amount not to exceed \$900,000, for the construction of a Senior Center at 31 & 33 Route 37 and authorize the issuance of \$900,000 bonds of the Town to meet said appropriation and expenditure to be used in conjunction with grants totaling \$1,298,000.00.
4. To consider and approve the resolution entitled "Resolution appropriating an amount not to exceed \$1,175,000, as recommended by the Board of Finance, for three fire trucks and authorizing the issuance of \$1,175,000 bonds of the Town to meet said appropriation and expenditure and pending the issuance thereof, making of temporary borrowings for such purpose".

5. To accept a gift contribution and the expenditure thereof in the amount of \$10,000 to the Park & Recreation Commission for equipment for outdoor movies.

Further notice is hereby given that the Board of Selectmen, acting pursuant to and in reliance on Section 7-7 of the Connecticut General Statutes, has removed Items #1, #2 and #4 for submission to the voters by machine vote at such date and time as may be determined at the Town Meeting, provided such date for the machine vote shall be no earlier than seven (7) days, and no later than fourteen (14) days after April 24, 2007, and further provided that such time shall be no less than the hours of 12:00 p.m. to 8:00 p.m. Also, please note that neither item #1 nor #2 shall pass unless both pass at the same time.
