The operation will mainly serve a small group of friends and family which account for one to two others who would use my services including myself.

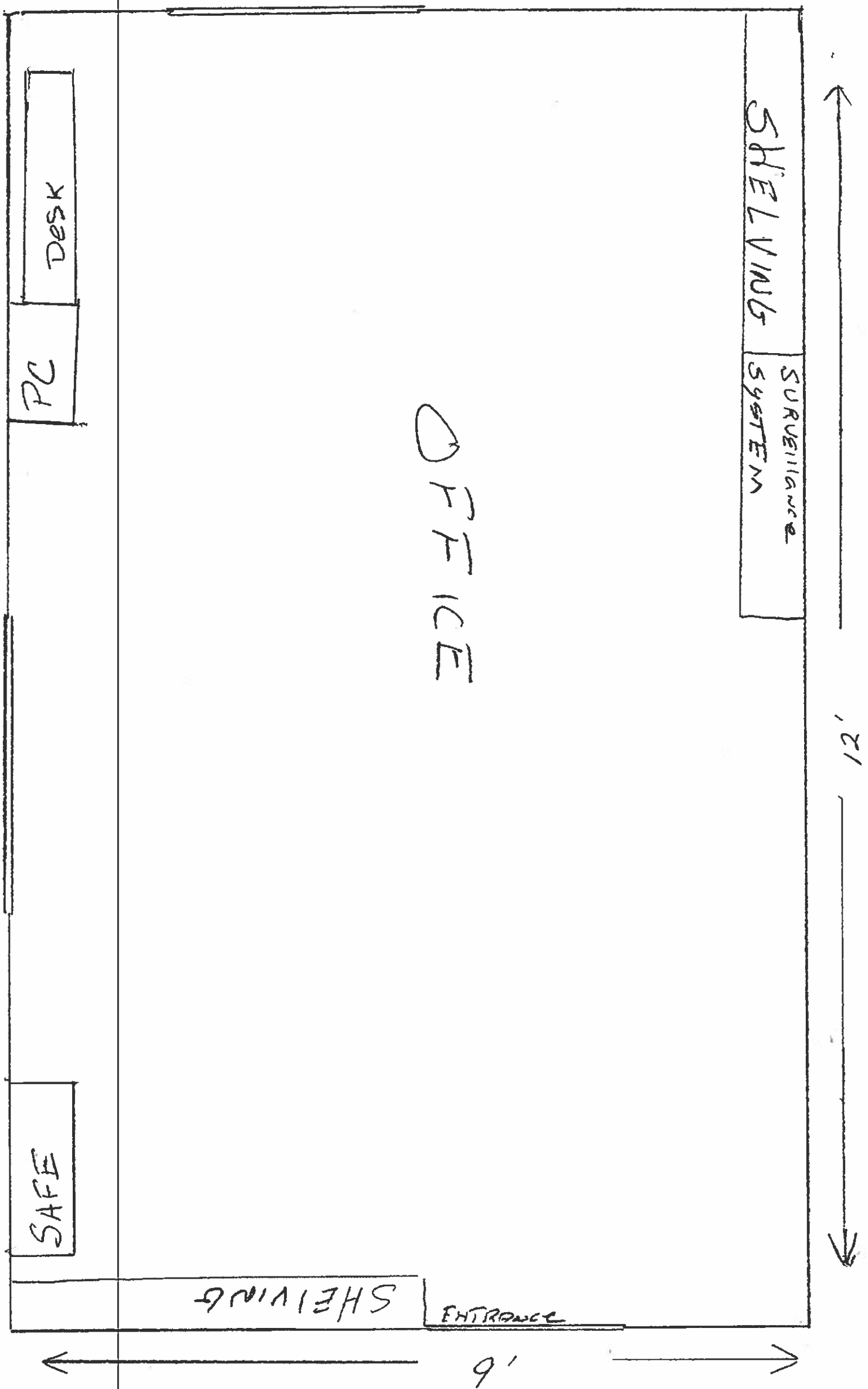
My reasoning for acquiring this operation is to save from exuberant costs gun dealers and brokers charge in buying and selling a weapon.
