Pat Del Monaco announced that there will be a Ribbon Cutting Ceremony for the new Consolidated School Early Learning Academy on Saturday, September 10<sup>th</sup> at 10:00am. Community tours will follow the ceremony.

The September 11<sup>th</sup> Remembrance Ceremony will be held on Sunday, September 11<sup>th</sup> at 5:00 pm.

New Fairfield Day will be held on Saturday, September 17<sup>th</sup> at Memorial Field. Selectman Khris Hall noted that the new variant booster shot will be available at the vaccination van at New Fairfield Fair Day

## **Preliminary 2021-2022 Surplus discussion**

Finance Director Olga Melnikov noted that the surplus for the 2021-2022 fiscal year is approximately \$980,000. She spoke of possible uses for this surplus which include:

- Enhancements to cyber security.
- Police Department Technology
- Cost of the Plan of Conservation and Technology
- Fire Department Operating surplus
- E-Finance Plus upgrade
- Medical Reserve Contribution
- Well testing required by the State
- Reduce negative balance at the Drop off Center
- Technology to allow for hybrid town meetings
- Fiber to connect Police Department to Firehouse
- Public Works items that were taken out of current budget

The total cost of these possible uses is approximately \$584,710.13. It was suggested that the remainder of the surplus go to the unassigned fund balance.

## Vote to approve Margerie Trail Resolution

Khris Hall spoke of the Margerie Trail Advisory Committee as a joint effort between New Fairfield and Danbury. She spoke of changes that Danbury made to their resolution which made the New Fairfield resolution outdated. As a result, an updated resolution from New Fairfield needed to be adopted. Changes to the resolution include the removal of references to the Candlewood Valley Regional Land Trust and an update to the funding amount. She noted that the charge of the committee remains the same and that over \$2 million of the state money has already been received.

Pat Del Monaco noted that the DEEP contract has been executed and the first meeting is scheduled for September 19<sup>th</sup>.

Pat Del Monaco made a motion to amend the Margerie Trail Resolution. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)** 

## **Vote to approve the Energy Efficiency Program**

Olga Melnikov spoke of energy programs available through Eversource that will result in long-term savings. She spoke of a partnership with the company Greenleaf that identified areas that will result in savings. She noted that the net cost to the town is approximately \$126,000. Eversource offers a

zero percent finance plan and savings are expected to be realized in about 3 ½ years. She noted that the Board of Education participated in a similar plan with great success.

Pat Del Monaco made a motion to accept the proposed scope of work from Greenleaf Energy Solutions and to allow the First Selectman to sign the letter of agreement with Eversource for nine buildings. Lori-Ann Beninson seconded the motion. **Vote: 3-0-0 (Motion approved)** 

### Vote to approve modifications to Hahlawah Shooting Range

Hahlawah Shooting Club President Anthony Yorio spoke of a request to use part of the parking lot to install a more modern shooting area. The approximate size of this area would 25 feet by 25 feet. This area would mostly be used for classes and would not increase the existing area and there is no intention to exceed the number of members in the club.

Pat Del Monaco made a motion to approve modifications to the Hahlawah Shooting Range to include a pit area consisting of three 20 foot berms in the existing parking lot. Lori-Ann Beninson seconded the motion.
