 SI-22-030 Site Plan Modification - 24 Gillotti Road For Modifications To The Approved Drawings To Match As-Built Conditions. Under Section 8.1 Site Plan Standards And Review process. Applicant PBC/Town Of New Fairfield. Chris Cardanay, Langan Engineering, he stated that there are three items in this application: landscaping, lighting, and playground.

Meredith Juliana, Langan Engineering, went over the relocation plants, shrubs, and trees. John Moran requested that the commission consider approving with the stipulation that he will inspect the plantings to make sure they were done according to the specification of each plant and sign off with his approval will be necessary.

Meredith Juliana went over the playground design. There are two areas one area for older children and the other are for younger children. There is a division between each age range. Each are having a variety of pieces of equipment.

Meredith Juliana stated that the lighting has two different pieces: the as-built light fixtures as well as the extra fixtures that are listed as to be installed. Kevin VanVlack questioned the lighting and Meredith Juliana stated that the lighting being added is new lighting. The new lighting will be added to the front of the building and along the back there will be one additional fixture, and one that will get a new distribution type. The current lighting had a few dark spots and the new fixtures will illuminate those areas. John Moran questioned if the parking lot lighting had all been completed. Meredith Juliana stated that the lighting has not been completed as of today. John Moran asked for a timeline on the addition of the lights. Christina O'Hare stated that the proposal time is in and is currently waiting for lead times for the project to be completed. Meredith Juliana stated that the bus loop drive meets the town zoning requirements. The additional lights are being added to meet the IES&A requirements. Christina O'Hare stated she will reach out to the contractor for a completion date.

Kevin VanVlack read in the letter to the commission from the Town Engineer, Tony Iadarola.

Tomas Kavaliauskas questioned if the new light fixtures will match what the current light fixtures are. Meredith Juliana stated that the newly installed light fixtures will match the current lights.

Mark Lamanna questioned if the new lighting could be a potential concern for those that live around the school. Christina O'Hare stated that the lighting is downlit, directional, and without any light spill.

Kevin VanVlack made a motion to approve SI-22-030 Site Plan Modification - 24 Gillotti Road For Modifications To The Approved Drawings To Match As-Built Conditions. Under Section 8.1 Site Plan Standards And Review process. Applicant PBC/Town Of New Fairfield. With the stipulations that they receive the approvals from the Zoning Commission Chairman to sign off on the plantings, a sign off by the Town Engineer and a sign off by the Zoning Enforcement Officer.
