Special Town Meeting

The Town Meeting was called to order by First Selectman Pat Del Monaco at 7:05 p.m. After the Pledge of Allegiance was recited, the call of the meeting was read by Holly Smith, Town Clerk. John Ransom made a motion to accept the call as read, seconded by John McCartney. Call passed by voice vote.

Pat Del Monaco asked for nominations for a Moderator. John McCartney made a motion to nominate Cheryl Reedy as moderator, seconded by John Ransom. Pat Del Monaco made a motion to close nominations, seconded by John McCartney. Hearing no further nominations, Pat Del Monaco declared Cheryl Reedy as moderator.

Moderator Reedy read Resolution #1 & #2

Resolution #1:

BE IT RESOLVED, that the amendment of an ordinance authorizing the Board of Selectmen to revise the tax abatement for volunteers, said ordinance to be codified by amending Chapter 16, Article II, Section 16-91 of the Code of Ordinances, New Fairfield, Connecticut, entitled "Sec. 16-91. Tax Abatement for Volunteers." be approved.

Resolution #2:

BE IT RESOLVED, that the amendment of the Ordinance, Chapter 2.5 Animals, Article II Dogs, defining Animal Control responsibilities within the Town of New Fairfield be approved.

Robert Jano made a motion to move the Resolution #1 to the floor for discussion, seconded by John Ransom. Moderator Reedy opened the floor for discussion. Hearing no discussion Moderator Reedy asked for a motion to close discussion and to vote on the resolution. Lee Scott made a motion to close discussion and a call for vote on the resolution, seconded by John Morelli. Moderator Reedy closed discussion and asked for a Vote on the Resolution.

Vote passed by a voice vote.

Pat Del Monaco gave a brief explanation of the Ordinance. John McCartney made a motion to close discussion and a call for vote on the resolution, seconded by John Ransom. Moderator Reedy closed discussion and asked for a Vote on the Resolution.
