Addition to the agenda

Khris Hall made a motion to add agenda item "Discuss and vote to reconvene the Traffic Authority. Pat Del Monaco seconded the motion. **Vote: 3-0-0 (Motion approved)**

<u>Vote to "Opt Out" of Subdivision (9) or Subsection (d) of Section 8-2 and Subsection (a)-(d) of Section 6 of the Connecticut General Statutes Public Act 21-29</u>

Pat Del Monaco noted that this would be to opt out of very specific provisions of the Zoning Enabling Act regarding accessory apartments and associated parking. She clarified that this has noting to do with Affordable Housing. Khris Hall spoke of her support for opting out and noted that this allows the town to retain control and flexibility for the future.

Pat Del Monaco made a motion that pursuant to Section 5 of Public Act 21-29 (P.A. 21-29), the Town of New Fairfield Board of Selectmen opts out of Subdivision (9) of Subsection (d) of Section 8-2 of the Connecticut General Statutes as amended by P.A. 21-29 for the following reasons:

• The Zoning Commission is in the process of reviewing its regulations and rewriting them and needs additional time to consider the changes required by Public Acct 21-29.

• Modifying parking without proper consideration of its implications in a predominately rural town with narrow roads without proper studies and time for consideration will result in potential safety hazards.

Lori Beninson seconded the motion. Vote: 3-0-0 (Motion approved)

Pat Del Monaco made a motion that pursuant to Subsection (f) of Section 6, the New Fairfield Board of Selectmen opts out of Subdivision (a)-(d) of Section 6 of Public Act 21-29 for the following reasons:

- The Zoning Commission is in the process of reviewing its regulations and rewriting them and needs additional time to consider the changes required by Public Acct 21-29.
- More public input will be necessary in making the types of revisions suggested by P.A. 21-29.

Khris Hall seconded the motion. Vote: 3-0-0 (Motion approved)

Discuss and vote on Fiscal Year 2021-2022 Surplus

There was a discussion among the BOS regarding the best uses for the fiscal year 2021-2022 surplus. They discussed possibly using the surplus for police cars and equipment, fire department apparatus, funding of the Plan of Conservation and Development and rolling shelves for the Town Clerk's vault.
