Library Board Chairman Linda Norris spoke of the proposed renovations to the Adult Library and asked the BOS to support this project in their budget. She noted that the approximate cost of this project is \$130,000 and they are requesting \$50,000 from the Town with the remainder coming from grants and fundraisers.

Pat Del Monaco noted that the Small Business Grant application is on the Town's website. This grant provides up to \$5,000 for eligible businesses

Khris Hall noted that 270 surveys regarding the Broadband study have been returned. The survey is available for a few more weeks and it is hopeful that a few more will be returned.

New Business

Grant from Connecticut Fair Plan

Fiscal Year 2023-2024 BOS Budget

Pat Del Monaco spoke of the budget for 2023-2024 and explained the process and the components that make up the Town's budget. She noted that this is a difficult year due to inflation, medical fund shortfall, school bonding and an increase in the paramedic service. She spoke of unappropriated capital and nonrecurring projects that are the most urgent and should be funded in this budget. She further spoke of the operating budget and the many pressures that accompany it this year. There was a brief discussion of department requests.

Khris Hall thanked both Linda Norris and Ellen Waltimyer for their support of the library and noted that it is hopeful that this project can be done in a future year.

The BOS recommended budget for 2023-2024 is \$13,911,420 which is an increase of \$645,831 or 4.87% from last year's budget.

Vote to release Barn Brook Brook Phase III Bond
