# **Margerie Trail Final Report**

Todd Fontanella from WESTCOG spoke of the project and introduced Senior Project Manager Marcy Miller from FHI.

Ms. Miller gave a presentation of the corridor study for Danbury and New Fairfield. She spoke traffic studies, major intersections, recommended changes and the feasibility of having a biking trail.

# Vote to set date and approve Town Warning for the Special Town Meeting to consider the 2020/2021 budget surplus

Pat Del Monaco made a motion to approve the following Warning for a Town Meeting to be held on Tuesday, November 9, 2021.

Notice is hereby given to the electors of the Town of New Fairfield and those entitled to vote at Town Meetings that a Town Meeting will be held on Tuesday, November 9, 2021 at 7:00 pm in the Community Room at 33 Route 37, in New Fairfield, CT, for the following purpose to wit:

1. To consider and act upon an authorization to apply \$722,268.14 of the 2020-2021 town budget as follows: \$2,268.14 to Fire Department Equipment Reserve Fund, \$60,000.00 to Capital and Non-Recurring Fire Co. (CoA Vinyl Siding), \$110,000.00 to Capital and Non-Recurring Police Cars and Equipment (Cameras), \$125,000.00 to Road Repair, \$425,000.00 to Purchase property located at 13 & 15 Route 37. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)** 

# OLD BUSINESS COVID Update

Pat Del Monaco noted that the infection rate for COVID in Town is up slightly and New Fairfield is currently in the "orange" zone. The vaccination rate for New Fairfield is lower than in surrounding towns.

Selectman Khris Hall noted that she is working with Candlewood Drugs for a pediatric (ages 5-11) vaccination clinic at the high school tentatively scheduled for Saturday, November 13<sup>th</sup> and Saturday, December 4<sup>th</sup>. There will be adult doses available as well and she encouraged anyone that has not yet been vaccination to do so.

Selectman Kim Hanson spoke of his disappointment regarding the low vaccination rate in New Fairfield. He encouraged anyone with concerns to talk to their health care providers or elected officials.

# American Rescue Plan update

Pat Del Monaco noted that this committee met on October 25<sup>th</sup> and discussed infrastructure including a sewer study and drainage repair. They discussed improvements to Company A Firehouse and Police Department Security measures. The group will prioritize these projects and will present to the Board of Selectmen.

First Selectman Del Monaco reminded everyone that the meetings of this working group are public meetings and open tot he public. She encouraged everyone to attend.
