New Business

Finance Year-End update

Finance Director Olga Melnikov gave a financial update for the fiscal year ending June 30, 2023. Revenue is expected to be approximately \$1.3 to \$1.5 million higher than budgeted due to unanticipated State revenue from the collection of sales tax and higher than expected interest income. There will be a Town Meeting to approve the transfer of some of the revenue surplus into the Medical Fund and Police Private Duty overtime. Expenditures for the fiscal year ending June 30, 2023 are on track to have a moderate surplus. The expenditure surplus is due to the reduction in the fringe benefit rates for State Troopers and unfilled positions in various departments throughout the year.

Olga Melnikov noted that the financial system in the Finance Department has been successfully updated. She gave a brief summary of the benefits of this new system.
