ARPA Project update

Pat Del Monaco noted that she received an update on the status of the projects that will be funded with ARPA funds.

<u>Beach House at Town Park-</u> Survey has been completed. An environmental assessment will need to be done to complete the demolition. It is hopeful that the demolition will be done by the end of the summer.

<u>Community Center Study</u>- Cindy White will be doing Focus Groups with residents to see what type of Community Center would be optimal.

<u>Company A Firehouse improvements</u>- This project is almost completed. Two EMT Rooms, a new mail room, a Fire Chief's office. Showers and gear washers were also added. Furniture for the EMT Rooms should be delivered this weekend.

<u>Ball Pond/Ore Hill Drainage Improvement Project</u>- An engineer was hired to do some design concepts for storm water detention and retention. It is possible that some of the funds could be used to purchase the property for detention and retention.

<u>Sanitary Sewer Design Project</u>- The final scope of work has been completed and the final design will begin soon. <u>Hazard pay for First Responders and Health Care Personnel</u>- Hazard pay has been distributed to First Responders and Health Care Personnel. Many small business grants have been issued.
