#### **Correspondence and Announcements**

Pat Del Monaco noted that there will be a Ribbon Cutting ceremony for the new high school on Saturday, September 23<sup>rd</sup> at 10:00am. Residents of the town will have an opportunity to tour the building at this time.

Selectman Khris Hall noted that New Fairfield Day has been rescheduled to Saturday, October 14<sup>th</sup>. There will be no rain date.

Selectman Lori Beninson spoke of a free service available from the Town Clerk that will check for property and mortgage fraud.

#### **Alzheimer's Proclamation**

Pat Del Monaco read a Proclamation for "Paint the Town Purple" in recognition of Alzheimer's Disease Awareness month. The entire BOS thanked everyone from the Alzheimer's Association Fairfield County Connecticut Chapter for all their hard work with this cause.

#### **Approval of Minutes**

Pat Del Monaco made a motion to approve the minutes of the regular meeting of August 24, 2023. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)** 

#### **Budget Transfers**

Finance Director Olga Melnikov gave brief description of the Intra-Departmental transfer which are needed for "true-ups" for the 2022-2023 fiscal year.

Pat Del Monaco made a motion to approve the Intra-Departmental transfer in the amount of \$42,168.00. Lori Beninson seconded the motion. **Vote: 3-0-0 (Motion approved)** 

Olga Melnikov spoke of Inter-Departmental transfer for the 2022-2023 fiscal year. She spoke of a transfer to the Medical Fund in order to mitigate a possible deficit. All three Selectmen noted that they were supportive of the transfer to the Medical Fund.

Pat Del Monaco made a motion to approve the Inter-Departmental transfer in the amount of \$384,229.00. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)** 

Olga Melnikov spoke of an Intra-Departmental transfer for fiscal year 2023-2024. She spoke of the reallocation of LOCIP funds as a source of funding for road repair.

Pat Del Monaco made a motion to approve the Intra-Departmental transfer in the amount of \$42,730.00. Lori Beninson seconded the motion. **Vote: 3-0-0 (Motion approved)** 

Pat Del Monaco made a motion to approve the transfer from Town Properties Capital Budget Building Repair Reserve Fund to Drop Off Center office in the amount of \$23,000.00. Khris Hall seconded the motion. **Vote: 3-0-0 (Motion approved)** 

#### **Approve Tax Refunds recommended by the Tax Collector**

Pat Del Monaco made a motion to approve the Tax Collector's refund requests for September 14, 2023 totaling \$4,215.61 as presented. Lori Beninson seconded the motion. **Vote: 3-0-0 (Motion approved)**

Pat Del Monaco made a motion to approve the contract between the State of Connecticut Department of Emergency Services and Public Protection Division of State Police and the Town of New Fairfield for the services of Resident State Troopers and to authorize the First Selectman to sign that contract.
