Vote to accept \$2.1 million COPS Grant

Pat Del Monaco noted that in order to accept this grant, an online account must be set up by the BOS. The entire BOS thanked Representative Jahana Hayes for all her work in securing this grant. It was noted that the Communications Ad Hoc Committee will reconvene in order to figure out the best use of this grant.

Pat Del Monaco made a motion to accept the COPS Grant in the amount of \$2.1 million from the US Department of Justice for the purpose of upgrading the Emergency Radio Communications System. Lori Beninson seconded the motion. **Vote: 3-0-0 (Motion approved)**

Vote to approve use of Senior Center ARPA (American Rescue Plan Act) funds

Pat Del Monaco noted that there are separate ARPA funds specifically for Senior Centers. It was decided to use this grant for facility improvements including installation of up to date audio and visual equipment throughout the Senior Center and training of staff in the system. The total of this grant is \$33,738.42.

Two notable changes are transferring to digital which will allow departments to communicate more easily with each other. The second change is allowing payments to vendors to be done by direct deposit thus saving both time and money for the Town.
