2) SP-23-020 – Special Permit for 13 Candlewood Road – For Excavation Work And Earth Removal Within 300 ft of the 440 Line Under Section 6.4 - Excavation, Removal, Filling, And Grading of Earth Material. Applicant Connor Roscoe.

Connor Roscoe, a contractor for 13 Candlewood Road, stated that this application is for a new retaining wall. The current retaining wall is collapsing due to the drain not working correctly. He went over the specifications for the new wall and stated that currently there is an approval with ZBA. The highest spot of the wall would be 10' which was approved by ZBA. Tomas Kavaliauskas questioned the parking. Connor Roscoe stated that there would be parking for four cars comfortably with the possibility of squeezing in five cars. Kevin VanVlack questioned the impervious surface. Evan White stated that the impervious surface would be addressed when permits were approved. Currently all permits have been pulled. Evan White requested that the specification be added that all permits are pulled and approved
