WHERAS, pursuant to State Statute, SGS Sec. 4-66G, the Connecticut Department of Economic and Community Development is authorized to extend financial assistance for economic development projects; and, WHEREAS, it is desirable and in the public interest that the Town of New Fairfield make an application to the State for \$475,272 in order to undertake the Town Green Project and to execute an Assistance Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE:

### **New Fairfield Board of Selectmen**

- 1. That it is cognizant of the conditions and prerequisites for the state financial assistance imposed by State Statute, SGS Sec. 4-66G
- 2. That the filing of an application for State financial assistance by the New Fairfield Board of Selectmen in an amount not to exceed \$475,272 is hereby approved and that First Selectman Patricia Del Monaco is directed to execute and file such an application with the Connecticut Department of Economic and Community Development, to provide such additional information, to execute such other documents as may be required, to execute an Assistance Agreement with the State of Connecticut for State financial assistance if such an agreement is offered, to execute any amendments, decisions, and revisions thereto, and to act as the authorized representative of the Town of New Fairfield.

Dear Pat, Khris and Lori-Ann,

On behalf of the Department I would like to thank the members of the current Board of Selectmen for your support of the Fire Department, our members and our programs over the last few years. We have very much appreciated your support.

There are four items that we have all verbally agreed to over the past 2-3 years that we request that you memorialize in your minutes at this last meeting so the new Board of Selectmen is made aware of them.

- 1. During the 2022-23 budget season you asked for cuts to the Fire Department budget that were not possible to achieve from our operating line and so we agreed that the Town, on a one-time basis only, could cut its annual contribution to the Apparatus Reserve Fund by \$50,000, as long as the \$50,000 was replaced in the fund sometime over the next 2-3 years. It was not possible to replace those funds during in the FY 23-24 budget so the amount of \$50,000 is still owed to the Fire Department Apparatus Reserve Fund in addition to the regular annual appropriation.
- 2. To take account of the inflationary costs of new fire and EMS apparatus, we reached a verbal agreement with the First Selectman that henceforth new ambulances needed by the Town would be purchased 100% using EMS user fees collected by the Department. The funding for ambulance purchases would no longer come from the Apparatus Reserve Fund and the Department but from the EMS checking account, understanding that such an agreement would cut revenue to the town in subsequent years when an ambulance purchase is necessary.
- 3. While the Department's ARPA renovation project located at Company A has been completed, we are all still waiting to make sure that the fix for the shower humidity issue will work as planned when winter is over and the weather warms again or whether additional air conditioning may be necessary. While all the funds allotted by the ARPA vote to the Fire Department project have been spent, the First Selectman noted at a Board

of Finance meeting that additional unspent ARPA funds are available if a bit more is needed to address the humidity issue in the showers next spring.

4. We have worked together with the Board of Selectmen over the last few years to improve the incentives available to those who volunteer for the NFVFD so that we can attract and maintain the members necessary to serve the town. Last year the Selectmen and a subsequent Town Meeting approved increasing the tax abatement available for members to the maximum \$2,000 per year allowed by a change in state law. We also agreed that a change in the Length of Service Award Program (LOSAP) the town provides for members was in order since the benefit had not been updated for more than twenty years. The Department Board of Directors decided to hold up on our request for a LOSAP improvement last year because of the other demands on the town budget, but we have been working with the Finance Director to have accurate numbers ready for the coming budget season for a number of different options that the Selectmen had already agreed to consider. We plan to request this improvement in LOSAP at budget time.

We think that if the current Board of Selectmen acknowledges in its minutes and by attaching this letter to the minutes or by some other means of your choice that these four unwritten agreements were made between the Selectmen and the Fire Department and that the Department has relied on them for its future financial planning, that it will make the transition easier for the new Board of Selectmen.

Thank you for your consideration of this request and for your service to our town. We wish Khris and Lori-Ann all the best in the future and look forward to continue working with you, Pat, on the new Board of Selectmen.
