Discussion of OSTA requirements for Speed Limits

Pat Del Monaco gave a brief description of changes for the State rules for determining speed limits on town roads. There is now a program that the Town would be able to opt-in to make its own determination regarding speed limits.

Police Officer Jason Cassavechia spoke of roads in Town that should have lower speed limits. Specific roads discussed were Warwick Road, Old Farm Road and Bigelow Road. There was a brief discussion of the challenges of speed bumps.

Selectman Khris Hall spoke of a possible petition from a New Fairfield resident regarding reducing the speed limit on Warwick Road.

Pat Del Monaco made a motion to notify the office of State Traffic Administration that the Local Traffic Authority of New Fairfield will establish, modify, and maintain speed limits on the roadways in New Fairfield. Lori Beninson seconded the motion. **Vote: 3-0-0 (Motion approved)**
