Budget – Cynthia Ross-Zweig stated that the available balance is \$4598.34. She also stated that all the allotted monies have been spent so currently waiting for BOF to come out with the new budget. She had inquired about petitioning for more funds and was advised since the funds needed would be more the \$25,000 it would require a town vote which would cost the town money. The Planning Commission does not currently have the funds to continue paying the consultant for the rework of the POCD. Keith Landa asked about the allocation of the funds and possibly petitioning the town for the funds. Cynthia Ross-Zweig stated that she is willing to write a letter to ask for the funds to continue with the POCD. The lack of funds will impede Planimetrics from continuing with the restructure of the POCD. The current plan is to petition the Board of Selectman and then wait for the town budget to be approved. A discussion was held on the budget and the amount of monies that will be approved by the Board of Selectman.

Gary Reetz made a motion to approve the payment of \$4,000 to Planimetrics. Keith Landa seconded the motion. **All in Favor (5-0-0). Motion passed.**
