Dear Board of Ed and Board of Selectmen Members,

My name is a Jena Alviti, and I live on Pondfield Road. As a sports parent and volunteer in town, player safety is always a top priority and front of mind. When the bus lot was "temporarily" moved to the school campus, we had concerns about access to JJP field. (My husband Jeff and others have brought it up at prior town meetings.)

I realize that our town has not yet agreed to the permanent location of the bus lot, but after witnessing a severe injury on Marty Morgan field this past week, it has become very apparent adjustments must be made immediately to the current set up.

The locked fencing around the temporary lot completely blocks all ambulance access to JJP field. The person or persons who have the key to this locked fencing will not always be available at the field in an emergency. After witnessing our ambulance response time to the high school being almost 15 minutes, I beg of you to make this small adjustment to the fencing to make emergency access to JJP possible.

Readjusting the fencing of that front corner of the temporary bus lot will allow quick and easy access to the field without anyone needing to move buses or find a key. My entire family was present when sixth grader Ryan Schwarz broke his leg in multiple places Friday night - not one coach on that field had a key to the gate that allows the ambulance to enter Marty Morgan field, not even Marty Morgan himself who was present at the time. Luckily, someone from the soccer program (I believe, I didn't catch his name) saw the chaos and ran over with a key that he just happened to have (it was not his personal key) and helped us open it just in time.

I don't need to tell you all that in an emergency, *every second counts*. This injury was a broken bone - the next one may be to someone's heart, brain, or spine. I feel that even having a key to the gates within the temporary bus lot specifically would not allow quick enough access for the ambulance to get through in an emergency. I have included pictures of what I am talking about, and hope that you will urgently consider rearranging the fencing in the corner of that temporary bus lot to avoid further liability issues and road blocks to safety in an emergency for our children who use that field every single day.

I have often heard the argument that if a player on the field is injured, they would be small enough to "carry up the hill" – but that is a very narrow viewpoint. We cannot control the extent of injury or to whom an injury occurs, and on any given day that field has players, coaches, parents, and even referees on it. If an adult has an immediate medical need down on that field, then what? It is also not proper emergency protocol for a coach or any citizen to move an injured player before EMS gets there, so that argument has zero merit.

So I am asking the boards to work together for two things immediately:

- 1. Move/rearrange the fencing in the corner of the temporary bus lot to provide ambulance access to JJP field.
- 2. Provide a key to the Marty Morgan field ambulance gate to *every* youth lacrosse coach. On my count, that would be around just 14 key copies. (We can use the same keys for whatever sport is in season and using that field.)

I know that these things cost money but the risk is far too great, especially since we no longer have a timeline of when those buses will ever get moved to a permanent location.

Thank you and I look forward to your response.
