### Special Town Meeting

The Town Meeting was called to order by First Selectman Melissa Lindsey at 7:00 p.m. After the Pledge of Allegiance was recited, the call of the meeting was read by Holly Smith, Town Clerk. Tom Perkins made a motion to accept the call as read, seconded by Cheryl Reedy. Call passed by voice vote.

Melissa Lindsey asked for nominations for a Moderator. Dan McDermott made a motion to nominate Cheryl Reedy as moderator, seconded by Jake Lindsey. Melissa Lindsey asked if there were any further nominations. Hearing none Melissa Lindsey made a motion to close nominations, seconded by Dan McDermott. Melissa Lindsey declared Cheryl Reedy as moderator.

Moderator Reedy welcomed everyone and explained the purpose and process for the Town Meeting. Moderator Reedy stated Resolution #1, #2 and #3 be removed for submission to the voters by machine vote at such date and time as may be determined:

#### Resolution #1

**BE IT RESOLVED**, that the appropriation of Town Government Expenditures totaling \$14,105,707 from the General Fund, and \$539,455 from the Capital and Non-Recurring Fund, and \$2,599,112 from other Governmental Funds, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2024 and ending June 30, 2025 be approved.

#### Resolution #2

**BE IT RESOLVED**, that the appropriation of Education Expenditures totaling \$55,071,776 from the General Fund, and \$119,577 from the Capital and Non-Recurring Fund, as recommended by the Board of Finance, for the fiscal year commencing July 1, 2024 and ending June 30, 2025 be approved.

#### Resolution #3

**BE IT RESOLVED**, that the advisory questions “is the Town Budget too high or too low” and “is the Education Budget too high or too low” be approved.

Moderator Reedy asked for a motion to set the date and time for the machine vote. Khrist Hall made a motion to hold the vote on Saturday, May 18, 2024 from 10:00 a.m. – 8:00 p.m., seconded by Samantha Mannion. Moderator Reedy called for discussion on the motion. After hearing no discussion, Moderator Reedy called for a vote on the motion to set the date for Saturday, May 18, 2024 from 10 a.m. – 8 p.m.

Vote passed by a voice vote.

Keith Landa made a motion to adjourn, seconded by John McCartney approved unanimously. Meeting adjourned at 7:06 p.m.
