I certify that to the best of my knowledge and belief each tax on the attached listing has not been paid, is uncollectible and should be transferred to the suspense rate book. Items transferred to suspense are removed from consideration as assets of the town but are not abated as a tax liability of the person against whom it was levied.

Please add this to the agenda for the next meeting. If the budget vote is June 8th, I am assuming the Board of Finance will be meeting shortly there after (June 10th). As I mentioned State Statute requires the Suspense List be approved by the BOF prior to the end of the fiscal year. The approved listing must then be filed with the Town Clerk. Once the list has been approved, it will be turned over to our collection agency. The collection agency's commission rate is 15% of what is collected. By Connecticut State Law, the town collects 15% of the commission fee from the taxpayer.
