### Call to Order

Board of Finance Chairman Joe Hart called the Board of Finance portion to order at 6:30pm. First Selectman John Hodge called the Board of Selectman portion to order at 6:31pm

### **Presentation of Senior Center Design and Construction Costs**

First Selectman Hodge gave a presentation and showed floor plans for the proposed Senior Center. Such floor plans include a great room/multi purpose room and storage areas. The great room could also be used for Town meetings, etc.

### Request for an appropriation of \$900,000 for Senior Center Construction

Funds needed from the town for the Senior Center are approximately \$900,000. Mr. Hodge explained the costs savings of what the town is currently paying in rent vs. buying and gave a 20-year projection of savings. Over a twenty year period, the town can expect to save approximately \$1 million in buying vs. renting a Senior Center.

Mr. Hodge opened the meeting to his fellow Selectmen to ask questions regarding the presentation.

There was a discussion regarding whether or not the Board of Finance was prepared to vote on this issue at this meeting. It was decided to allow the Board of Finance members to have until 5:00pm on Wednesday, April 11<sup>th</sup> to submit questions to the First Selectmen regarding the Senior Center. The Board of Finance members will be copied on the questions that are submitted. There will be a Board of Finance meeting on Friday, April 13<sup>th</sup> at 7:00pm to go over the questions submitted by the Board of Finance.

There was a discussion as to the timing of the meetings and Public Hearing. It is desired to have the Senior Center vote with the same referendum with the 2007/2008 budget referendum.
