Discussion of Historic House Move Direct Costs

Members of the Board of Finance asked questions of First Selectman John Hodge regarding the "direct costs" of moving the Historic Houses. The houses are scheduled to be moved on Sunday, March 4th. A lengthy discussion ensued regarding what exactly is a direct costs and what work was done by the Public Works Department.

<u>Legal Update</u>

First Selectman John Hodge spoke of areas that are in need of a transfer due to legal matters. A transfer in the amount of \$45,000 is requested to pay for legal fees. There was a discussion regarding legal expenses.

Joe Hart made a motion to make an Inter-Departmental transfer (**Town Meeting required**) in the amount of \$45,000 **from** line item # 4160-140 (salary adjustment) in the amount and \$20,000 and line item #4151-801(BOF contingency) in the amount of \$25,000 **to** line item #4161-332-2 (Legal-Tax) in the amount of \$15,000, line item # 4161-332-1 (Legal-Land Use) in the amount of \$15,000, line item # 4161-332-7 (Legal-Zoning) in the amount of \$5,000 and line item # 4161-332-8 (Legal-ZBA) in the amount of \$10,000 for a total of transfer of \$45,000. Ron Graiff seconded the motion. (Such document to be attached to the minutes of this meeting).

Joe Hart amended the previous motion to change the amount of line item #4151-801 (BOF contingency) from \$25,000 to \$15,000 and to change the amount of line item #4160-140 (salary adjustment) from \$20,000 to \$30,000 for a total transfer of \$45,000. Ron Graiff seconded the amendment.
