#### Senior Center and Small Cities Grant update

First Selectman John Hodge spoke of the progress of the Senior Center. Modular companies have been contacted regarding building the Senior Center.

First Selectman John Hodge spoke of Small Cities DECD grants in the amount of \$650,000.

#### Legal Update

First Selectman Hodge agreed that a budget transfer to put money back into the BOF contingency fund will be done at the June 28<sup>th</sup> Board of Selectman meeting.
