Finance Director Update

Finance Director Jay Waterman announced that the fiscal year 2006-2007 audit has started this week. According to preliminary unaudited figures, the town is expected to return approximately \$420,000 in unexpended general fund expenditures from the operating budget. Revenues were exceeded by approximately \$619,000 for a total of approximately \$1,040,000.

Legal Update

Jay Waterman spoke of the legal budget for fiscal year end 2006-2007. Mr. Waterman spoke of the "monetary litigation recovery" and read into record an e-mail he wrote to BOF Alternate Bob Carbone regarding the "monetary litigation recovery".
