Joe Hart spoke of correspondence following up on an e-mail from the April 2nd meeting about the school building project. This will be addressed later on in the meeting.

Board of Education Chairman Kim Hanson spoke of his personal priorities for cuts to the budget.

Approval of Minutes

Joe Hart made a motion to approve the minutes of the April 2, 2008 meeting as presented. Al Mardis seconded the motion.

Vote: 6-0-0 (Motion approved)

Discuss and vote on 2008/2009 recommended budget

Joe Hart went over a list of previously recommended cuts that he would like to see back in the budget. Members of the Board of Finance gave their comments regarding specific line items. A lengthy discussion ensued regarding the budget line items.

There was a discussion regarding whether or not money needs to be put in the 2008-2009 for services from the architect and construction managers for the potential school projects.

Joe Hart made a motion to endorse the list of reductions as previously discussed. Al Mardis seconded the motion.

Vote: 6-0-0 (Motion approved)

Wes Marsh made a motion to amend the previous motion to remove \$20,000 from Technology Equipment. Jane Landers seconded the motion.

Vote: 4-2-0 (Motion approved) (Wes Marsh, Jane Landers, Al Mardis and Tom Wahlig in favor) (Joe Hart and Lucy DiRocco opposed)

Wes Marsh made a motion to amend the original motion to reduce the Technology para in the amount of \$25,000. Lucy DiRocco seconded the motion.

Vote: 1-4-1 (Motion denied) (Wes Marsh in favor, Joe Hart, Lucy DiRocco, Jane Landers and Tom Wahlig opposed, Al Mardis abstained)

Recess

Joe Hart made a motion to take a recess at 9:10pm in order to finalize the numbers for the final mark up. Al Mardis seconded the motion.

Vote on final Mark Up

Joe Hart made a motion to recommend to a Town Meeting the Board of Finance recommended budget consisting of the following. Municipal expenditures totaling \$9,938,920 from the General Fund, municipal expenditures from the Capital and Nonrecurring Fund \$904,950 and \$773,171 from other governmental funds and Educational expenditures from the General and Capital and Nonrecurring Fund totaling \$34,904,144 which results in a Mil Rate increase of 3.41% and 20.64 Mils. Al Mardis seconded the motion.

Resident Rudy Bahrens spoke of the school budget in New Fairfield

First Selectman John Hodge, Director of Parks and Recreation Steve Merullo and Parks and Recreation Commission Chairman Ray Lubus individually spoke of the need for bathrooms and a concession stand at the turf field. First Selectman Hodge noted that he would like to see this as a separate line item question on the referendum for budget vote.

Board Member Comments

Members of the Board of Finance spoke of the budget process. The BOF members thanked everyone involved in the budget process and acknowledged all their hard work.
