### **Correspondence and Announcements**

Al Mardis read two e-mails sent from BOE member Monika Thiel regarding contract liabilities for the BOE Building Projects. In response to these e-mails Chairman Joe Hart requested the following items from BOE Chairman Kim Hanson, Superintendent of School Dr. Joseph Castagnola, Director of Management Services Mike Santogatta and First Selectman John Hodge.

These items include:

- 1. Who is responsible for these costs? BOE or Town?
- 2. Could this potential liability be encumbered in the 2007-2008 budget? If not, should the potential liability be added to the 2008-2009 budget?
- 3. What is the cost of the potential liability?
- 4. What is the cost incurred to date?
- 5. Are costs continuing to be incurred?
- 6. The BOF would like to see a copy of the contract.

#### **Public Comment**

Board of Finance Chairman Joe Hart went over the budget process and spoke of the requested budgets.

Dozens of residents and administrators spoke of the proposed budget cuts and specifically the proposed cuts to the school budget. A petition was submitted by over 400 taxpayers opposing the proposed cuts to the school budget. (Attached to the minutes of this meeting) A second petition was submitted by current eighth grade students regarding freshmen sports. (Attached to the minutes of this meeting)

#### **Amendment to Agenda**

Joe Hart made a motion to change the agenda to put agenda item #9 "Discuss and review budget cuts for the Town of New Fairfield for 2008-2009" as agenda item#7A ahead of agenda item #8 "Discuss and review budget cuts for the Board of Education for 2008-2009". Jane Landers seconded the motion.

#### Discuss and review budget cuts for the Town of New Fairfield for 2008-2009

First Selectman John Hodge spoke of the proposed \$500,000 worth of cuts for the 2008-2009 town budget. Mr. Hodge spoke of the town's fund balances and compared the town's general fund to that of other towns. Mr. Hodge noted that New Fairfield has one of the strongest general fund balances in the area. There was also a discussion of the medical fund balance and the capital and nonrecurring fund. There was a discussion regarding taking money out of the capital and nonrecurring fund to pay for capital and nonrecurring expenses. Mr. Hodge spoke of suggested cuts to the budget such as road repair. It was decided that the BOF will go over specific line items at the April 9<sup>th</sup> BOF meeting. Mr. Hodge also spoke of his desire to have the vote for a concession stand and bathrooms at the turf field as a separate vote at the referendum.

Chairman Joe Hart thanked both the BOS and the BOE for all their hard work throughout the budget process and especially all the work done in the past week to prepare for this meeting.

#### Discuss and review budget cuts for the Board of Education for 2008-2009

Brian Shea thanked the students who came out in support of the budget. Dr. Castagnola also thanked all the students and families who came out and supported the budget at recent meetings.

Dr. Castagnola noted that the BOE met on March 31<sup>st</sup> to discussed proposed cuts but no formal action was taken. Dr. Castagnola spoke of the impact of budget cuts and the long-terms effects of drastic cuts. A list of possible cuts were given to the Board of Finance prior to tonight's meeting.

Joe Hart gave out a spreadsheet that catorgorized the proposed cuts into eight sections. The sections include Regular Education, Special Education, Administration, Support Services, Sports, Revenue and Capital. There was a discussion regarding prioritizing the cuts cutting administrative costs over costs for direct education. There was a discussion about adding back \$116,000 from utilities.

#### **Public Comment**

Some residents and BOE members Vic Flagello and Ralph Langham spoke of the education budget.

#### **Board Member Comments**

Members of the Board of Finance spoke of their opinion of the cuts and specifically their desire to have the cuts come from administrative cuts instead of direct education expenses.
