## Presentation of the Board of Education Requested Budget 2009/2010

Superintendent of Schools Dr. Joseph Castagnola presented the Board of Education requested budget for 2009/2010 and gave a power point presentation. The total BOE's requested budget for 2009/2010 equals \$35,876,576 for a 2.79% increase over the 2008/2009 budget. This percentage represents a dollar amount increase of \$972,432. Dr. Castagnola spoke of the status of the economy and noted that the 2.79% increase was needed to fund all current services and no additional money is being requested for the 2009-2010 school year. Dr. Castagnola spoke of the \$200,000 for attrition and noted his concern

that teachers are not as likely to leave the school district in this economy. Dr. Castagnola also noted that New Fairfield received the Carol White Pep Grant for Physical Education and thanked former Assistant Superintendent of School John Boccuzzi for securing this grant.

Dr. Castagnola introduced all the administrators and thanked the administrators, the teachers, the Board of Education and everyone involved for all their work in putting the budget together.

The Board of Education will answer more questions concerning the budget at the Board of Finance meeting on Wednesday, March 25<sup>th</sup> at 7:30 in the High School library.
