Discussion of the Board of Education requested budget for 2010-2011

Superintendent of Schools Dr. Castagnola thanked everyone involved in putting together the budget and all who attended tonight's meeting. A spreadsheet was provided that showed the impact of cutting \$895,734.00 from the requested budget. Dr. Castagnola spoke of the impact of these potential cuts. There was a lengthy discussion of these potential cuts with the main topics of conversation being class size, reduction of teachers and/or administrators and attrition. Fuel Oil and diesel fuel was discussed as well as pay for play and elimination of certain activities and sports.
