<u>Appointments</u>- Jane Landers made a motion to elevate Brian Shea for tonight's meeting in Tom Edwards' absence. Tom Wahlig seconded the motion.- Vote: 5-0-0 (Motion approved)

Discuss and recommend to a Town Meeting the use of 2009/2010 surplus money for bridge and drainage

improvements- First Selectman John Hodge spoke of the bridge project for Williams Road and noted that he received a letter from "Earth Movers" who are the contractors for Smoke Hill Drive and Old Farm bridges. Earth Movers noted their intention to hold the current contract price until October 1, 2010 so that the town can add Williams Road to the contract if approved at a Town Meeting. Mr. Hodge noted that the Board of Selectmen voted immediately prior to this meeting in favor of using \$250,000.00 of the 2009/2010 budget surplus for the Williams Road bridge. The quote for the Williams Road bridge was \$266,910.00

There was discussion among the Board of Finance members and the first selectman regarding the timing of the projects and how the Williams Road bridge project will affect other road projects in town. There was a discussion of grants and a discussion of surplus money. There was a discussion of whether \$200,000 or \$250,000 should be taken from the surplus.

Al Mardis made a motion that the Board of Finance recommend to a Town Meeting an appropriation of \$250,000 for the Williams Road Bridge project from the 2009/2010 budget surplus. Tom Wahlig seconded the motion. Vote: 4-2-0 (Motion approved- Wes Marsh, Al Mardis, Brian Shea and Tom Whalig in favor, Jane Landers and Robert Klick opposed)

Al Mardis made a motion to adjourn the meeting at 9:05pm. Jane Landers seconded the motion. **Vote: 6-0-0 (Motion approved)**
